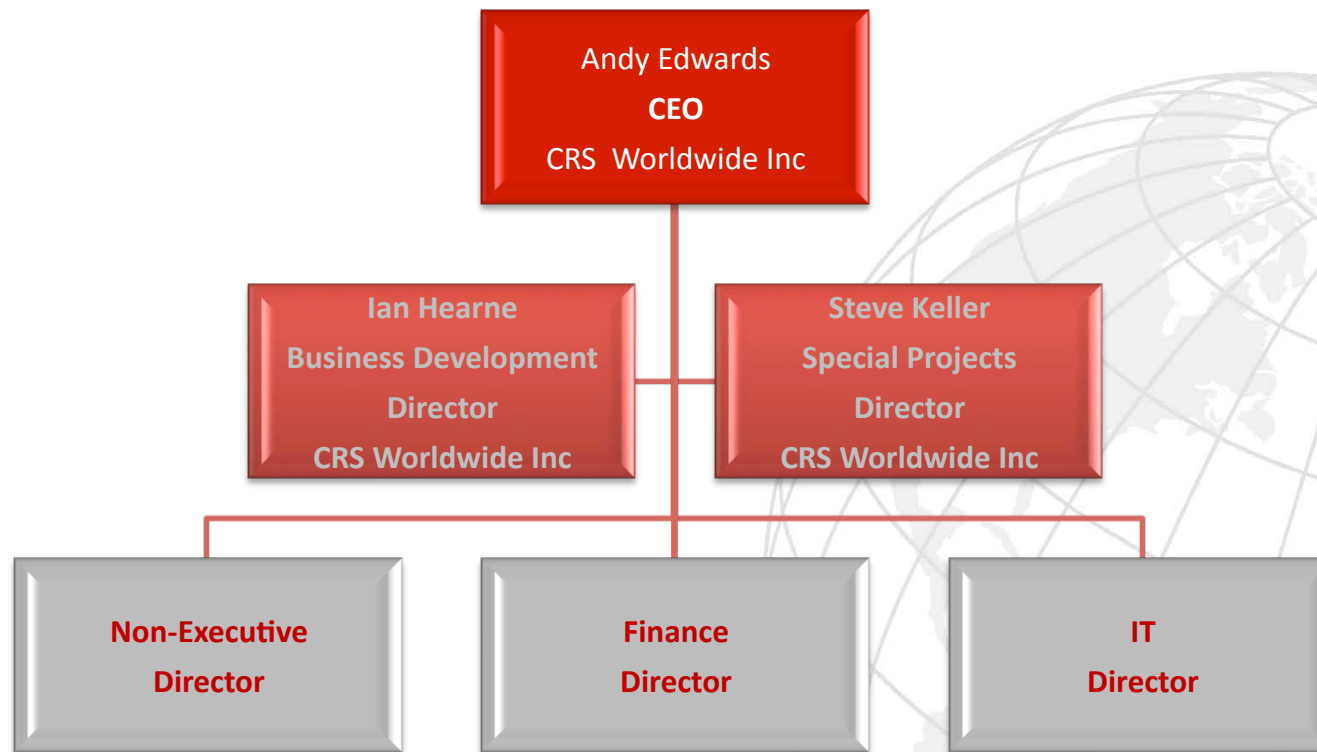

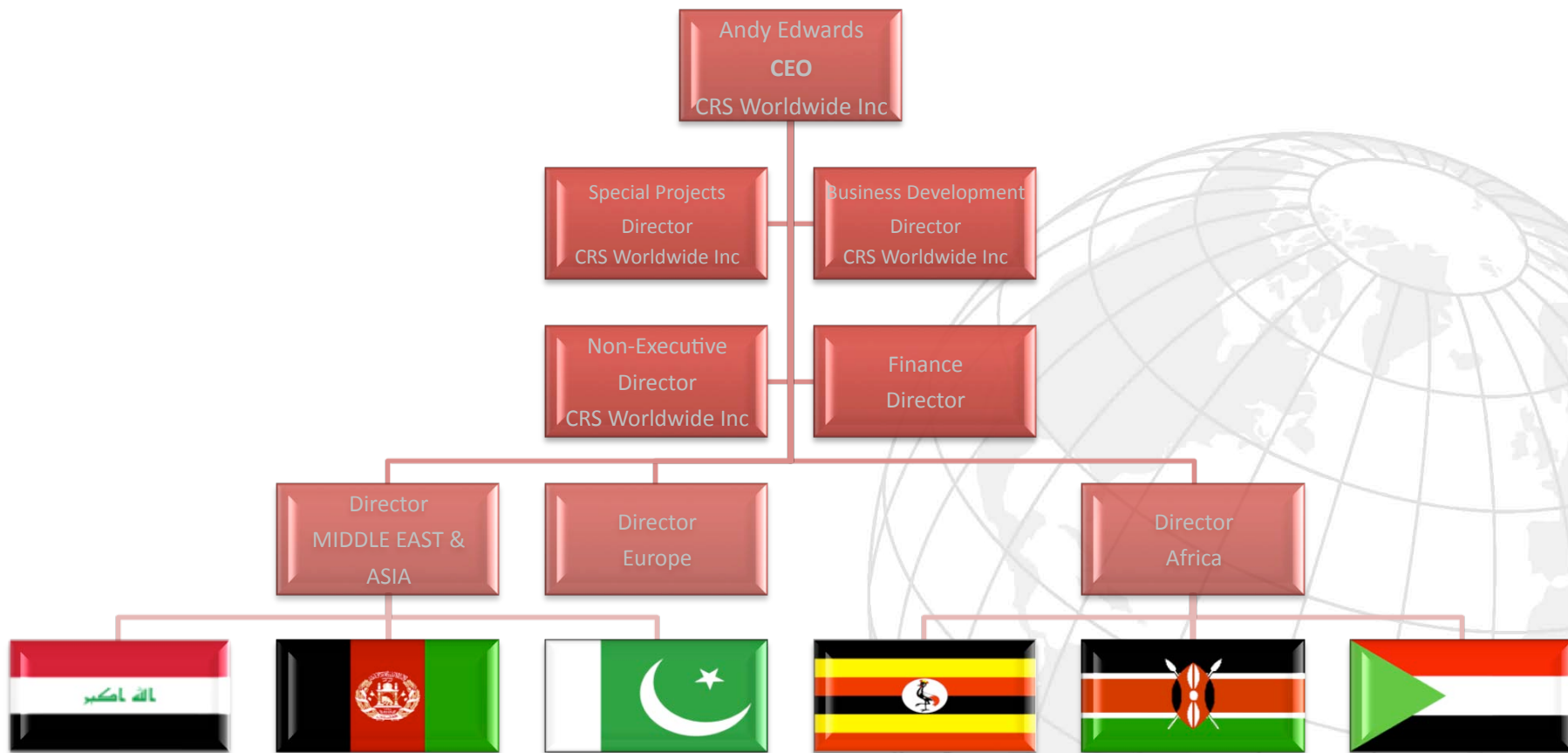

The Montreux Document

- CRS is pleased to confirm that it welcomes and abides by the principles set out in the “**Montreux Document on Pertinent International Legal Obligations and Good Practices for States related to Operations of Private Military and Security Companies during Armed Conflict**”
- Whilst the Montreux Document reaffirms the **obligation on States** to ensure that private military and security companies operating in armed conflicts comply with international humanitarian and human rights law, **CRS have been actively working to the same guiding principle since our formation over six years ago.**
- The document is the product of an initiative launched cooperatively by the **Swiss government and the International Committee of the Red Cross.** It was developed with the participation of governmental experts from **Afghanistan, Angola, Australia, Austria, Canada, China, France, Germany, Iraq, Poland, Sierra Leone, South Africa, Sweden, Switzerland, the United Kingdom, Ukraine, and the United States,** in meetings convened in January and November 2006, November 2007, and April and September 2008. Representatives of civil society and of the private military and security industry were consulted.

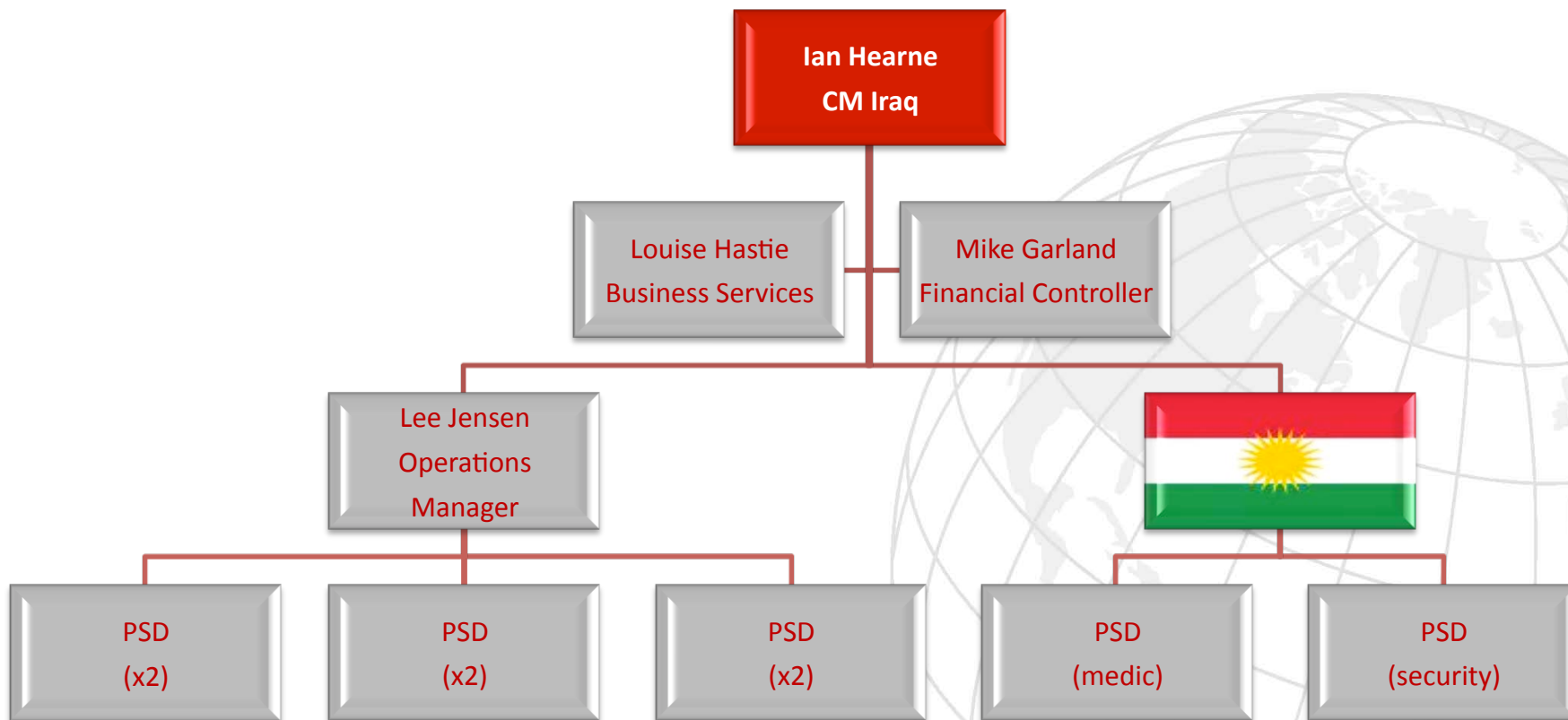
