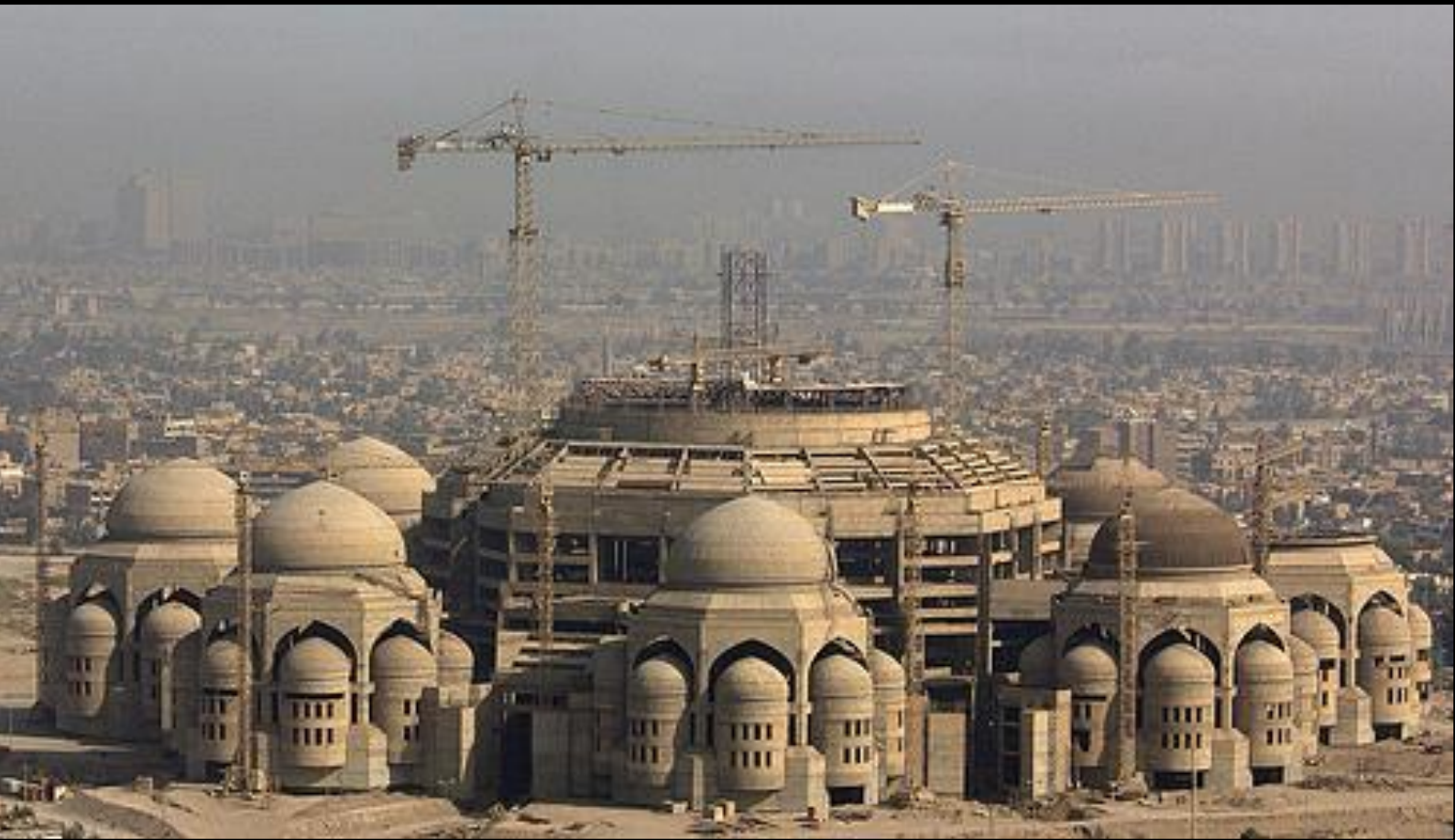

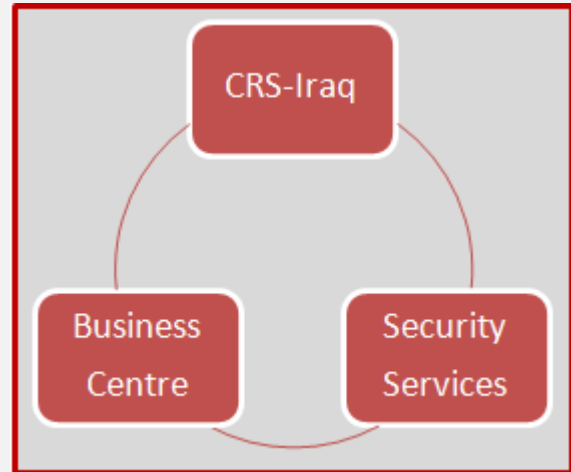

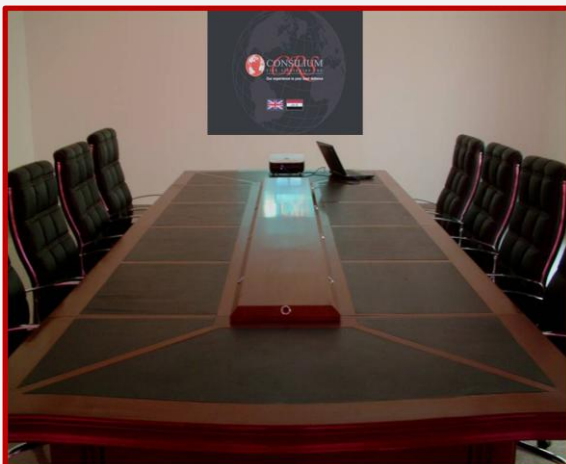

However, given the increasingly violent nature of the situations in which relief agencies find themselves, what steps should be taken to ensure the safety of their workers? To what extent should armed guards be employed to protect staff, and how ethical is it to do this if agencies profess non-violence?
